In addition, in the event that the account is referred to an attorney for collection, the Customer agrees to pay NSH's reasonable attorney's fees. This agreement may not be amended or modified unless in writing and signed by a duly authorized officer of NSH. You are authorized to check my bank and credit history at this time or any other time North Sea Hardware deems necessary. Customer shall remain fully responsible for account balances until all sums due and payable under this Credit Agreement are paid in full. NSH may continue to allow authorized individuals to charge hereunder unless and until it receives written notice from Customer by certified mail, return receipt requested, terminating the account. NSH shall have the right to terminate the Agreement or reduce Customer's credit line at any time, without notice.
